- (iii) No advance payment shall be made.
- (iv) The firms shall submit their bill in triplicate at the time of supply of articles.
- (v) The Court reserve the right to accept or reject any or all quotations.
- (vi) Copy of latest Income Tax return/ Sale tax clearance Certificate, Sales tax registration Certificate, VAT Number and PAN be furnished along with the tender.
- (vii) Payment will be made through Bank Draft, not in Cash, after delivery and inspection of the goods. In case any defect is found in any of the material, the concerned firm shall replace it immediately free of cost.
- (viii) An earnest money of 5% of purchase value in the form of Bank Draft in favour of the Registrar General, Patna High Court will also be required to be deposited in the Court which is refundable at the time of final deal.
- (ix) The successful bidder shall supply the articles for a minimum period of one year on the approved rate which may be extended for a further period of one year, if agreed bilaterally.
- (x) The quantity of the articles may be increased or decreased as per the requirement.
- (xi) The supply order may be given on quarterly basis or as per the requirement of the court.
