The Technology Must Become A Constitutional Instrument, Not A Mere Administrative Tool; Hon'ble Mr Justice Surya Kant, The Chief Justice of India



In a landmark keynote address delivered at the West Zone Regional Conference held by the National Judicial Academy at Jaisalmer on December 13, 2025, the Chief Justice of India, Hon'ble Mr. Justice Surya Kant, called for a fundamental paradigm shift in the judiciary's relationship with technology. Speaking on the theme "Advancing Rule of Law through Technology," the CJI asserted that digital tools

must transcend their current role as mere administrative aids. His Lordship emphasised that technology must be reimagined as a "constitutional instrument" that actively strengthens equality before the law and expands access to justice for every citizen, rather than simply digitizing existing bureaucratic bottlenecks.

Central to this vision is the adoption of a "Unified Judicial Policy" designed to dismantle the long-standing regional barriers between various High Courts. By creating a single, cohesive national judicial ecosystem with shared standards and seamless interfaces, the CJI aims to provide a consistent experience for litigants across the country. Hon'ble Mr. Justice Surya Kant further described predictability

as the "soul of the rule of law," noting that technology can ensure judicial outcomes are rooted in established principles by making precedents more accessible and cross-referenced, thereby fostering a sense of certainty and fairness in the legal process.

Practical applications of this digital shift are already bearing fruit, particularly in the prioritization of urgent matters. The CJI highlighted how new digital flagging systems now identify sensitive cases, such as bail petitions and habeas corpus, ensuring they are listed for hearing within just two days of filing. This optimization serves to protect personal liberty by reducing the time spent in procedural limbo.

Nevertheless, Hon'ble Mr. Justice Surya Kant, moderated his endorsement of technological

innovation with a critical caveat regarding social inclusivity.

He maintained that for any digital reform to be considered true progress, it must remain accessible to the marginalized, the elderly, and those lacking digital literacy. Without such safeguards, he cautioned, the transition to a high-tech judiciary would constitute a "regression" rather than an advancement, potentially alienating the very citizens the law is sworn to protect. For the judiciary to truly evolve, the CJI concluded, technological advancement must be inclusive and human-centric, ensuring that the march toward a digital future does not leave the most vulnerable members of society behind.

eCommittee's eCourts Training Drive Reaches 21,017 Participants Nationwide; Strategic Capacity Building Across India



In a landmark effort to strengthen a technology-enabled judiciary, the e-Committee of the Supreme Court of India successfully executed a series of nationwide training and outreach initiatives throughout December 2025. Conducted in close

collaboration with State Judicial Academies, this intensive campaign comprised 43 specialized programs, reaching an unprecedented 21,017 participants across multiple tiers of the judicial ecosystem.

Broad Spectrum Training: The initiative was designed to benefit a diverse group of stakeholders, including:

- Judicial Officers
- Court Managers
- Administrative Staff
- Technical Personnel
- Advocates and Advocate Clerks

By addressing the needs of each segment, the campaign ensured that the entire judicial framework is equipped to embrace digital transformation.

Infrastructure & Security Readiness: Specialized training sessions for technical teams focused on:

- Hardware and software maintenance
- Video Conferencing (VC) management
- Cybersecurity protocols

These modules strengthened the backbone of court operations, ensuring resilience, reliability, and secure digital functioning.

Empowering the Grassroots: Recognizing the importance of inclusivity, outreach programs were extended to Taluk and Village levels. Rural legal practitioners were trained in:

- Essential computer skills
- Digital case management tools

This grassroots empowerment ensures that access to justice is not limited by geography, but is equally available to communities across India. With this expansive training drive, the e-Committee of the Supreme Court of India has reinforced its commitment to digital excellence, inclusivity, and transparency, paving the way for a judiciary that is future-ready and citizen-centric.

Refresher Training on Cyber Laws & Digital Evidence at Judicial Training and Research Institute, UP



On 04.12.2025 and 18.12.2025, the Judicial Training and Research Institute (JTRI), Uttar Pradesh facilitated two intensive refresher training sessions under ECT_14_2025, focusing on the technical dimensions of Cyber Laws and the Appreciation & Handling of Digital Evidence.

163 Judicial Officers of the High Court attended these sessions, which were designed to equip participants with the strategic framework necessary for technology-enhanced adjudication.

Curriculum Highlights: *The program offered a comprehensive deep dive into:*

- Internet Jurisdiction – Understanding the complexities of cross-border digital interactions.
- Intermediary Liability – Examining responsibilities of online platforms and service providers.
- Emerging Cyber-Offense Patterns – Identifying new trends in cybercrime and their implications for judicial processes.

By combining technical expertise with judicial application, JTRI's training has strengthened the capacity of High Court Judicial Officers to navigate the digital legal frontier with confidence, precision, and accountability.

Digital Transformation: Strengthening the Judicial Ecosystem Through Comprehensive Training by Maharashtra Judicial Academy



The month of December 2025 marked a significant milestone in the technological evolution of the district judiciary in Maharashtra. Through a series of specialized programs, thousands of stakeholders—ranging from veteran advocates to frontline court staff—were equipped with the digital competencies required to navigate the modern legal landscape.

Empowering the Bar: Advocate and Clerk Training

ECT_4_2025: District Headquarters

Initiative: From December 12 to 28, 2025, the District Headquarters hosted a digital empowerment program tailored for the legal community. A total of 1,088 advocates and clerks participated in sessions designed to integrate eCourts India services into their daily workflows, ensuring that the transition from paper-based to digital filings remains seamless and efficient.

ECT_7_2025: Expanding Reach to Taluk and Village Levels: To ensure no practitioner was left behind, a massive outreach initiative was conducted between December 7 and December 31, 2025. Led by Advocate Master Trainers, this program successfully trained 4,626 participants across various clusters.

The curriculum focused on the "nuts and bolts" of the digital ecosystem, including hands-on instruction in e-filing, National Service and Tracking of Electronic Processes (NSTEP) protocols, and video conferencing etiquette.

Optimizing the Bench: Staff and Personnel Refresher Modules

ECT_8_2025: Modernizing Process Service with NSTEP:



The Judicial Academy spearheaded a critical three-day refresher program on December 4, 7, and 27, 2025, focusing on the NSTEP software. Training 844 personnel, including Administrative Heads and Process Servers, the sessions emphasized the

transition to end-to-end digital flows. By mastering GPS-enabled real-time tracking for summons and notices, the staff has significantly enhanced the transparency and speed of the district's service mechanisms.

ECT_9_2025: Advancing Digital Competencies for Court Staff



A specialized module conducted on December 7, 14, and 21, 2025, targeted the broader administrative body, updating the skills of 2,956 District Court staff members. The training aligned personnel with the latest eCourts advancements, specifically;

- **Virtual Courts:** Digital management of Traffic and Transport matters.
- **e-Sakshya:** Navigating the platform for digital evidence.
- **CIS 4.0 & NJDG:** Leveraging Case Information Systems and the National Judicial Data Grid for real-time monitoring and data management.

Digital Judicial Renaissance: West Bengal Judicial Academy Strengthens ICT Capacity



The West Bengal Judicial Academy spearheaded a series of intensive training programs throughout December 2025, aimed at fortifying the technological infrastructure of the state's legal system. These initiatives reflect a strategic commitment to digitizing the judiciary, from high-level technical maintenance to the daily workflows of judicial officers and the Bar.

Fortifying the Infrastructure: Technical Staff Training

ECT_11_2025: Strengthening the Technological Backbone: Between December 1 and 20, 2025, a large-scale capacity-building program was conducted for 108 technical staff members, including District System Administrators and System Officers. The curriculum covered critical ICT domains such as

hardware and software maintenance, data replication, LAN connectivity, and video conferencing management. By enhancing these specialized skills, the Academy has ensured that the

Judicial Leadership: Empowering Officers on the Bench

ECT_13_2025: Computer Skill Enhancement (Level I & II): On December 8, 2025, a group of 22 Judicial Officers from all cadres of the District Judiciary participated in a practical skill-building session. The training focused on the integration of ICT into daily court operations, specifically covering PDF accessibility tools, speech-to-text utilities, server basics, and data security. These hands-on demonstrations were designed to support the judiciary's transition toward paperless workflows, directly increasing the efficiency and digital autonomy of officers on the bench.

"technological backbone" of the courts remains resilient, supporting the effective operation of modern judicial systems through professionalized technical oversight.

ECT_14_2025: Masterclass in Cyber Laws and Digital Evidence:

A specialized refresher program was held on December 10, 2025, for 22 Judicial Officers to address the complexities of the digital legal landscape. The sessions focused on cyber-enabled offenses, the handling of digital evidence, and jurisdictional challenges inherent in the digital space. By providing updated insights into intermediary responsibilities and emerging cybercrime trends, the initiative strengthened the capacity of the judiciary to adjudicate contemporary technology-driven disputes with precision.

Bridging the Gap: Empowering the Bar and Registry

ECT_4_2025 & ECT_7_2025: Advocate and Clerk eCourts

Programme: From December 5 to 18, 2025, the Judicial Academy extended its reach to the Bar, training 370 Advocates and Clerks across District Headquarters and Taluk Courts. The comprehensive modules included orientation to eCommittee projects, e-Filing workflows, and the preparation of accessible PDFs. This program emphasized the critical role of the Bar in driving digital transformation, ensuring that legal practitioners are fully equipped to utilize state portals and e-service

kiosks for a more streamlined filing process.

ECT_15_2025: High Court Registry

Refresher Training: On December 6 and 20, 2025, a refresher training program was organized for 100 technical and non-technical staff members of the High Court Registry. The training focused on boosting administrative productivity through digital technologies and updated procedural knowledge. By aligning registry functions with technology-enabled workflows, the program has significantly improved the efficiency of daily High Court operations and internal administrative practices.



Digital Empowerment: Chhattisgarh Judicial Academy Scales Up Technical Training for District Judiciary



On December 20, 2025, the Chhattisgarh Judicial Academy reached a significant milestone in its mission to modernize the legal landscape, conducting two intensive, large-scale training sessions. Designed to accelerate the transition toward a paperless and tech-driven judiciary, these programs saw the active participation of 448 Judicial Officers, underscoring a statewide commitment to delivering faster and more transparent justice through the eCourts platform.

ECT_13_2025: Computer Skill Enhancement (Levels I & II) This session was strategically designed to move beyond basic computer literacy and focus on the practical digital demands of modern courtrooms. The curriculum provided hands-on demonstrations in advanced office suite applications, speech-to-text utilities, and PDF accessibility tools to streamline judicial drafting. By mastering networking fundamentals and data security protocols, the participating officers are now better equipped to maintain secure,

efficient workflows and manage the increasing digital caseload with heightened technical proficiency.

Advanced Systems Integration:

ECT_16_2025: eCourts Integrated Programme: Conducted simultaneously across all District Headquarters, this high-level orientation focused on the operational architecture of the eCourts Project Phase III. Judicial Officers received specialized training on the National Judicial Data Grid

(NJDG) and the Inter-operable Criminal Justice System (ICJS) integrations to ensure seamless data sharing across the legal ecosystem. A primary priority of the session was the standardization of hybrid hearing protocols and digitization strategies, ensuring that e-Filing and electronic services are implemented with total uniformity across the state's judicial districts.



Digital Induction: Delhi Judicial Academy Equips Judges for the Future



In a strategic push to modernize the capital's legal infrastructure, the Delhi Judicial Academy successfully conducted two high-impact integrated induction programs this December. These sessions were specifically curated for newly recruited judicial officers, ensuring that from their very first day on the bench, they are prepared to navigate and lead within a digital-first judicial environment.

Laying the Digital Foundation for the Junior Division: ECT_17_2025: Integrated Induction for Civil Judges: On December 10 and 11, 2025, the Academy hosted an intensive two-day induction for 48 newly appointed Civil Judges (Junior Division). This program was designed to bridge the gap between traditional legal theory and modern digital practice. Through interactive, hands-on modules, the young judges mastered the core pillars of the eCourts ecosystem, including the

Case Information System (CIS), the National Judicial Data Grid (NJDG), and various e-Filing platforms. By focusing on these essential tools, the training ensures a seamless integration of technology into their daily judicial duties and case management workflows.

Strategic ICT Orientation for the District Judiciary

ECT_18_2025: ICT & eCourts Induction for Direct District Judges: A specialized program was held on December 16 and 17, 2025, for 10 newly recruited Direct District Judges. Recognizing their role in

supervising district-level judicial administration, this induction provided foundational training in digital court infrastructure and advanced ICT tools. The curriculum emphasized how to leverage technology to achieve greater transparency and accessibility in justice delivery. By empowering these senior recruits with technical proficiency, the Academy is ensuring that the leadership of the district judiciary is fully equipped to drive the transition toward a more efficient, tech-enabled legal system.



Jharkhand Judicial Academy: Spearheading a Paperless Future



In a concerted effort to modernize legal operations, the Jharkhand Judicial Academy rolled out two specialized training modules this December. These initiatives targeted different tiers of the legal hierarchy, focusing on personal digital proficiency and the systematic conversion of physical records into a secure electronic repository.

Upskilling the Bench: District-Level Technical Mastery
ECT_13_2025: Computer Skill Enhancement (Level I & II): On December 12, 2025, a massive

synchronization of technical skills took place across the District Headquarters of Jharkhand. A total of 168 Judicial Officers participated in a comprehensive curriculum designed to refine their ICT competencies. Beyond fundamental hardware and software orientation, the session emphasized advanced word processing and spreadsheet management. This training ensures that the District Judiciary can navigate the complexities of modern caseloads with greater speed and technical autonomy.

The Digital Archive: High Court Transformation- ECT_6_2025: Specialized Digitization Workflow:

Shifting focus to the High Court level on December 14, 2025, the Academy conducted a technical intensive for 37 Officials and Staff members. This program was meticulously aligned with the national eCommittee guidelines, providing a deep dive into the lifecycle of a digital document. Participants engaged in rigorous training covering:

- **Metadata & Scanning:** Establishing standards for PDF/A, OCR, and ICR practices.
 - **Document Lifecycle:** Mastering pre-scanning preparation and post-scanning archival protocols.
 - **Quality Assurance:** Implementing strict control measures to ensure the integrity of the High Court's secure digital repository.
- By professionalizing the document management process, this initiative creates a more accessible and permanent record system for any judicial forum.



Digital Fortification: Karnataka Judicial Academy Elevates Technical Proficiency



Throughout December 2025, the Karnataka Judicial Academy rolled out a multifaceted training roadmap designed to sharpen the technological edge of the state's legal machinery. By addressing everything from courtroom management to the intricate "backbone" of IT infrastructure, these initiatives ensure a robust and future-ready judicial environment.

Optimizing Bench Performance and Modern Courtroom Management: Empowering the District Judiciary On December 1 and 17, 2025, a massive cohort of 902 Judicial Officers underwent intensive instruction on the essentials of contemporary court administration. Led by expert Master Trainers, the curriculum of ECT_16_2025 bridged the gap between traditional law and

modern digital tools. Key focus areas included the mastery of Case Information System (CIS) modules, streamlined e-Filing workflows, and the technical nuances required to conduct seamless hybrid hearings. This large-scale effort ensures that digital innovation is not just an add-on, but a core component of daily district court operations.

Technical Resilience: Supporting the Digital Ecosystem : Fortifying Infrastructure and Systems Recognizing that a digital court is only as strong as its underlying technology, a dedicated session ECT_11_2025 was held on December 11 and 12, 2025, for 39 technical staff members, including System Administrators and Officers. This intensive "engine room" training focused on the critical maintenance of hardware, data replication protocols, and LAN connectivity. By

reinforcing these skills, the Academy aims to ensure zero downtime for essential digital services, providing a stable platform for both litigants and the bench.

The Frontier of Justice: Adjudicating Cyber-Enabled Crimes: ECT_14_2025: Specialized Mastery of Digital Evidence To address the complexities of modern high-tech crime, a focused refresher course on Cyber Laws was conducted across four dates: December 11, 12, 29, and 30, 2025. A select group of 60 Judicial Officers engaged in advanced training regarding the handling, appreciation, and legal admissibility of electronic evidence. This program ensures that the judiciary remains highly proficient in navigating the sophisticated legal proceedings associated with cyber-enabled offenses and digital forensics.

Technological Fortitude: Tamil Nadu Judicial Academy Sets New Training Benchmarks



In a massive push toward operational excellence, the Tamil Nadu Judicial Academy executed two of the largest digital training drives of the year this December. By targeting both the specialized technical architects and

the vast administrative workforce of the state's legal system, the Academy has significantly fortified the efficiency and resilience of the judicial machinery.

The Architects of Stability: Technical Workshop for NIC and Staff- ECT_10_2025- Strengthening the Digital Backbone: On December 12, 2025, the High Court served as the hub for a high-level technical intensive involving 2,460 Technical Staff and NIC Coordinators. The workshop was meticulously designed to ensure absolute digital stability across the state's courtrooms. Participants engaged in specialized modules covering hardware and software maintenance, data replication protocols, and the sophisticated management of Video Conferencing (VC) and Local Area Network (LAN) systems. This proactive approach ensures that the technological infrastructure remains robust, minimizing disruptions during critical judicial proceedings.

A Digital Surge: Refreshing the District Judiciary's Frontline- ECT_9_2025: Large-Scale Administrative Empowerment: Transitioning from infrastructure to human capital, the Academy hosted a staggering refresher program on December 20, 2025, for 5,268 staff members of the District Judiciary. Centered on the core objectives of the eCourts project, the initiative provided comprehensive training in modern data and process management. By broadening the digital proficiency of such a vast number of personnel simultaneously, the Academy has accelerated the speed of service delivery at the district level, ensuring that the benefits of the eCourts mission reach every litigant in the state.

Madhya Pradesh Judicial Academy Advances Cyber & IT Competence



The targeted sessions conducted by Madhya Pradesh Judicial Academy in December 2025 marked a significant step in equipping both judicial and technical personnel with the knowledge and tools required to navigate the digital era of justice.

Cyber Law & Digital Evidence (ECT_14_2025): On 16.12.2025, a total of 49 Judicial Officers participated in a comprehensive refresher course designed to strengthen their expertise in technology-driven adjudication. The program covered evolving

cybercrime patterns, forensic evidence preservation, and the complexities of internet jurisdiction.

Court IT Systems Training (ECT_11_2025): On 21.12.2025, 61 Technical Staff, System Administrators, and System Officers underwent intensive training focused on maintaining robust IT infrastructure across District Courts. The session emphasized practical competencies such as data replication, LAN connectivity, and the operation of video conferencing equipment.

Manipur Judicial Academy: Advancing Technical Self-Reliance in District Courts



The Manipur Judicial Academy organised a comprehensive one-day training program featuring ECT_7_2025 and ECT_11_2025, aimed at enhancing the operational and digital capabilities of technical personnel across District Courts.

ECT_7_2025 – Advocates & Clerks:

On 20.12.2025, the Manipur Judicial Academy conducted ECT_7_2025, a one-day program attended by 28 Advocates and their clerks. The training emphasized practical, field-oriented problem-solving with a

focus on hardware and software maintenance, data replication, data monitoring, LAN connectivity, and video conferencing equipment management. The session aimed to strengthen digital readiness and operational efficiency for legal professionals supporting court processes.

ECT_11_2025 – Technical Staff & System Officers:

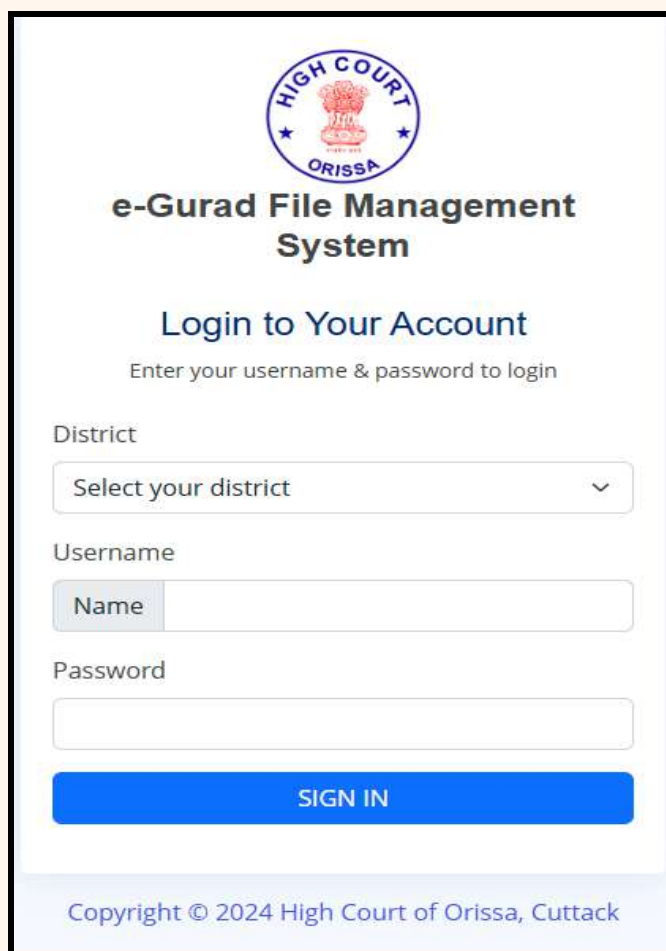

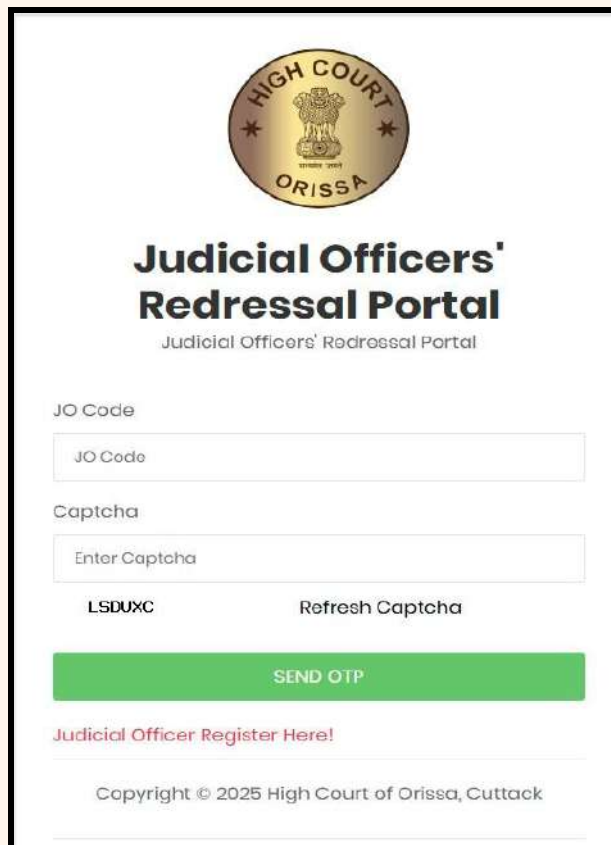

These reforms mark a significant leap toward a modern, transparent, and technology-driven judicial system.

e-True Copy Module: A citizen-centric service enabling instant digital true copies of court documents from both the Rajasthan

High Court and District Courts. Through the Digitized Record Management System (DRMS), applicants can apply online, pay fees, track requests, and receive authenticated e-copies with QR codes, UDRN, and digital hash values. This initiative ensures efficiency, transparency, and trust in judicial documentation.

WhatsApp Chatbot – SULAH: Launched to support mediation and alternative dispute resolution (ADR), the SULAH chatbot assists courts at the pre-referral stage by screening

cases and obtaining party consent seamlessly. By reducing non-starter cases and making mediation user-friendly, this tool represents a smart, tech-enabled approach to justice delivery.

Paperless Courts for NI Act Cases:

Following the success of paperless commercial courts, two pilot paperless courts dedicated to Negotiable Instrument Act cases will be introduced in Jodhpur Metro Judgeship and Jaipur Metro-II Judgeship. Equipped with modern hardware, these courts promise quick, efficient, and cost-effective adjudication.

Expansion of e-RHC Portal: The RHC e-Portal, inaugurated earlier in March 2025, has now been expanded with five new modules:

- e-Service Book – Digital archive of officers' service records.
- e-Annual Confidential Report – Fully online evaluation process.

- Extra Duty Allowance Processing System – Automated approvals for additional responsibilities.
- Calendar Event Management System- Real-time scheduling and coordination.
- Legal Researcher Management System – Streamlined appointments and certification for researchers.

Indigenous Display Board

Software-ePATAL: Developed entirely in-house, ePATAL integrates urgent mentioning, real-time updates, court information, and instant messaging into a unified platform. 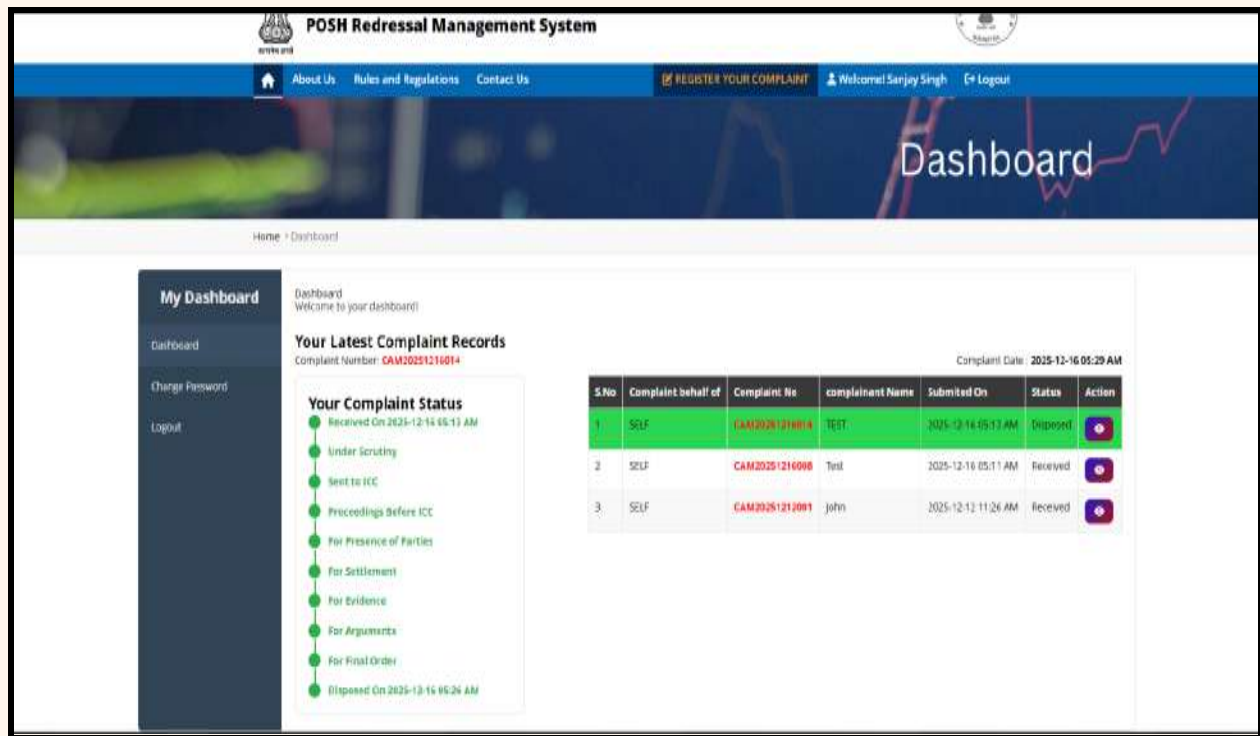
The green-tick verification mechanism provides instant validation of digitally signed eSummons, guaranteeing their authenticity, integrity, and trustworthiness.

Transparency, Accountability & Accessibility: The POSH Redressal Management System is designed to strengthen workplace safety by providing a structured, transparent, and accessible mechanism for all women employees. Whether permanent, temporary, contractual, or interns, every individual working within the judicial system of Uttarakhand can rely on this platform for secure grievance handling.

Secure & Role-Based Workflow: The system incorporates OTP-based authentication and a role-based

workflow, ensuring confidentiality, authenticity, and accountability at every stage of the grievance process. By enabling structured complaint submission, real-time monitoring, and transparent resolution, the portal represents a significant step toward digital governance in judicial administration.

With the launch of the POSH Redressal Management System, the High Court of Uttarakhand has reaffirmed its commitment to workplace safety, transparency, and efficiency, setting a strong example of how technology can be harnessed to protect rights and foster trust within the judiciary.

The e-Office application transforms traditional manual processes into streamlined, secure, web-based operations. It introduces digital

workflows, eFile management, knowledge management, and collaboration tools, thereby creating a paperless, efficient, transparent, and accountable environment. By digitizing file movement and administrative processes, the system enhances speed, ensures data integrity, and supports faster decision-making. This implementation marks a significant step toward building a judiciary that is future-ready, technologically empowered, and citizen-centric.
