***Senior most Civil Judge (Senior Division), excluding Civil Judge (Senior Division)-cum-C.J.M. at the station and those officers who have not been found fit for promotion to the higher post, shall be designated as Civil Judge (Senior Division)-I-cum-A.C.J.M.-I in the light of 'Bharatiya Nagarik Suraksha Sanhita, 2023' after effecting the above transfer & posting subject to approval of the Hon'ble Court.}***
