- (3) Original Certificate of Diploma in Computer Applications.
- (4) Photocopies of all the certificates as asked for above and also the photocopy of the Engagement Letter alongwith two self attested recent passport size photographs.
- (5) Self declaration of criminal antecedent or pending criminal case, if any, on affidavit sworn by the Candidate.
- (6) Original Medical Fitness Certificate from any Asstt. Civil Surgeon.
