DISTRICT JUDGE (ENTRY LEVEL),

DIRECT FROM BAR EXAM – 2016

On scrutiny of the application forms and documents uploaded by the candidates who have qualified in the Main (Written) examination of District Judge (Entry Level), Direct from Bar, 2016, certain discrepancies have been found. The same have been indicated against the names of the candidates in the chart attached herewith. The candidates are directed to do the needful as indicated below –

1. The candidates who have not uploaded the required documents/declaration on the website of the court, may upload the same on the website of the court on or before 12.02.2018 and bring the documents on the respective dates of their interview failing which they will not be allowed to appear at the interview.
2. The candidates who have left antecedent columns vacant in the application forms and the candidates in whose names/fathers' names, spelling mistakes have been found, may clarify their position on affidavit which they have to submit on the respective dates of their interview.
3. The candidates in respect of whom clarifications are required regarding enrolment/experience certificates, may clarify their position on affidavit which they shall bring at the time of interview.

4. The candidates who are judicial officers and also those serving in some other organization having 7 years of experience as advocate are provisionally being allowed to appear at the interview and their candidature shall be considered later on in light of the legal position settled by the Hon'ble Supreme Court in the cases of Deepak Aggrawal vs. Keshav Kaushik and Others, Civil Appeal No. 561 of 2013 [arising out of SLP (C) No. 17463 of 2010] and Vijay Kumar Mishra & Another vs. High Court of Judicature at Patna & Others, Civil Appeal No. 7358 of 2016 [arising out of SLP (C) No. 17466 of 2016]
5. The candidates who are judicial officers but do not have 7 years of experience as advocate are provisionally being allowed to appear at the interview and their candidature shall be subject to the decision of Hon'ble Supreme Court in the Writ Petition (Civil) No. 733/2016 and in light of the legal position settled by the Hon'ble Supreme Court in the cases of Deepak Aggrawal vs. Keshav Kaushik and Others, Civil Appeal No. 561 of 2013 [arising out of SLP (C) No. 17463 of 2010] and Vijay Kumar Mishra & Another vs. High Court of Judicature at Patna & Others, Civil Appeal No. 7358 of 2016 [arising out of SLP (C) No. 17466 of 2016].
6. The candidate having roll no. 14362 has to explain on affidavit as to under what circumstances he had to leave his job of Additional District & Sessions Judge from UP Higher Judicial Service.
7. The candidate having roll no. 15395 has prima facie been held ineligible to appear at the interview because of not having 7 years of experience as advocate and also being in full time corporate employment and not practicing as advocate, and also in view of Rule 49 of BCI Rules.
8. The candidates against whom criminal cases are pending are provisionally being allowed to appear at the interview subject to

condition that they shall submit on affidavit the present status and nature of their cases alongwith the copy of the FIR and their candidature shall be considered after submission of documents at the end of interview process.

If any candidate fails to remove the defect as pointed out in his/her individual case, his/her candidature will be liable to be rejected.
