## NOTICE

### District Judge (Entry Level), Direct from Bar Exam-2020

It is for information to the candidates who have been selected for interview under District Judge (Entry Level), Direct from Bar Exam- 2020 that upon 1<sup>st</sup> stage scrutiny / verification of the application forms and documents uploaded by them in light of the Court's Notice dated 23.07.2021, certain discrepancies have been found.

The same have been indicated against the respective names of the candidates in the tabular chart (annexed herewith as Annexure-I) and accordingly they are directed to remove the defect(s) as pointed out in his / her individual case and to bring the required documents with them on the respective dates of their interview.

Details of discrepancies found upon Scrutiny and steps to be taken by the candidates for removal of the same are broadly mentioned below –

1.	Some candidates have not uploaded their Matric / Intermediate / Graduation / LL.B. Certificates.	The candidates are directed to bring the required documents / certificates / declarations on their respective dates of interview failing which they may not be allowed to appear at the interview.
2.	Some candidates have either not uploaded Declaration regarding their income / 24 Cases or have uploaded the same but not as per the requirement.	
3.	Some candidates have left columns regarding antecedent, post held, details of graduation etc. vacant in their online application forms.	The candidates are directed to clarify their position on affidavit which they have to submit on their respective dates of interview.
4.	Spellings of Names / Father's Name entered by several candidates in their online application forms are not matching with that mentioned in their certificates or vice versa.	
5.	Some candidates have committed mistakes / errors in mentioning their correct date of enrolment in online application form.	

6.	Signature on the application forms / documents uploaded in case of some candidates do not match with their name as entered in their online application form.	The candidates are directed to make alteration in their signature matching with their name and an undertaking to that effect is to be submitted; otherwise their candidature will be withheld.
7.	Some candidates have mentioned regarding criminal cases filed against them in their online application form.	The candidates against whom cases are pending, provisionally allowed to appear at the interview subject to the condition that they submit on affidavit the present status and nature of the case along with the copy of the FIR and bring / produce the same on their respective dates of interview.
8.	Several candidates have written regarding their additional qualification in online application but they have not uploaded the certificates in respect of the same. Although it is fact that in the Court's Notice (referred to above) it is not said so.	The candidates are directed to bring with them the documents / certificates in support of their additional qualification(s) as mentioned in their online application form and produce the same on their respective date of interview.
9.	Some candidates who are in service have either not uploaded 'No Objection Certificate / Permission from employer' or have uploaded the same but there is no mention about permission specifically to appear in the said interview.	The candidates are directed to bring 'No Objection Certificate / Permission from employer' which specifically mentions about no objection or permission regarding participation / appearance in the interview to be held under District Judge (Entry Level), Direct from Bar Exam-2020 and produce the same on their respective dates of interview or latest by 26.08.2021 i.e. the date on which the interview will be concluded.
10.	Some candidates have either not uploaded Experience Certificate or uploaded but the same is not as required.	The candidates are directed to bring with them the up-to-date Experience Certificate and produce the same on their respective dates of interview.
11.	Some candidates belonging to BC / EBC category have not uploaded Caste Certificate or have uploaded the same but there is no mention about Creamy Layer or the same is prior to one year as on date.	The candidates of BC / EBC category who have not uploaded Caste Certificate or have uploaded but there is no mention about Creamy Layer, are directed to bring with them the recent Caste Certificate showing that they do not belong to creamy layer and produce the same on their respective

		date of interview. Further, who have uploaded their Caste Certificate mentioning / showing that they do not belong to creamy layer but the same is issued prior to 1 year as on date, they are directed to produce a Declaration in prescribed proforma (Form-XVIII B) in light of the letter No. 15440 dated 05.12.2017 of the General Administration Deptt., Govt. of Bihar (annexed herewith as Annexure-II) on their respective dates of interview
12.	Some candidates belonging to BC / EBC category have not uploaded Residential Certificate or have uploaded the same but not proper.	The candidates are directed to bring with them the Residential Certificate showing permanent resident of Bihar on their respective dates of interview.

If any candidate fails to remove the discrepancies as pointed out in his/her individual case, his/her candidature will be liable to be rejected.

Further, if any other discrepancy(ies) is found in their documents/certificates or required at the time of interview, the candidates may be asked to submit an undertaking to remove the same or to furnish the required documents within the specified period.

Candidates are requested to keep visiting the website of the Patna High Court regularly for further updates.
