2) Details of vacancies are as under-

SC - 06 (including 2 for women)

- 3) No candidate could qualify under SC category. Further, against 6 vacancies reserved for EBC category, only 1 candidate could qualify. However, 1 candidate of EBC category also qualified under UR category.
- 4) A Tabular Chart containing relevant details alongwith marks obtained in Main (Written) Examination and interview (viva voce test), in respect of all the candidates, who were called for interview is enclosed herewith. In the said chart, "Qualified" column specifies whether the candidates obtained minimum qualifying marks or not.
- 5) Category wise merit list of finally selected candidates, in detail, is also enclosed herewith.
- 6) Further, the candidates of select list, with curable defects in their applications / documents, will have to rectify the defect(s) within one month after the receipt of the notice failing which their respective recommendation / appointment would be cancelled. - 7) The marks obtained by all the candidates who appeared in the Main (Written) Examination will also be uploaded on the website of the Court soon.
