## STENOGRAPHER RECRUITMENT EXAMINATION, 2022

### NOTICE

The final result for appointment to the post of Stenographer under Advertisement no.PHC/01/2022 for Stenographer Recruitment Examination, 2022 is being published alongwith this notice for information to all concerned. The candidates must take notice of following facts which have been taken into consideration for preparation of final result:

1. Total 275 candidates who had attained the minimum qualifying standard in the Computer Based Written Test comprising English Shorthand-Computer Typing Test, Multiple Choice Question based Objective Test and English Computer Typing Test as prescribed in the clause 7 (i), (ii) & (iii) of the Advertisement no.PHC/01/2022 were called for appearing in the interview.
2. The candidates who have attained the minimum qualifying standard in the interview as prescribed in the clause 7 (iv) of the Advertisement no.PHC/01/2022 have been considered for preparation of final result. The marks obtained by a candidate in the Computer Based Written Test alongwith marks obtained in the interview have been taken into consideration.
3. Candidates securing marks equal and above the marks secured by the last candidate selected in Unreserved Category have been placed in the Unreserved Category while other candidates have been placed in their respective category of reservation.
4. If two or more candidates have secured equal marks, the candidate securing higher marks in the written test has been placed above and if the marks obtained in the written test are also equal, then the candidate born earlier has been placed above.
5. The result has been prepared after following the 100 point roster-reservation policy adopted in the establishment of Court at the time of advertisement. The names of candidates are in order of merit and their category of selection is indicated against their names at Annexure-I.
6. The prepared result comprises 55 candidates under UR Category including 18 female candidates, 13 candidates of EWS Category including 01 female candidate, 10 candidates under BC Category including 01 female candidate, 12 candidates under EBC Category including 01 female candidate & 03 candidates under SC Category.

Out of total 93 candidates, 02 candidates of OH Category have been horizontally placed in their respective category.

7. The Cut-Off marks for each category is as follows:
