Revised Result of the Preliminary Test held on 06.03.2022 (Sunday) under the District Judge (Entry Level), Direct from Bar Exam-2021 in view of the order dated 31.01.2023 passed by the Hon'ble Division Bench of the Patna High Court in MJC No. 2612 of 2022 in modification of its judgment dated 11.08.2022 in CWJC No. 9089 of 2022 titled Amit Kumar Vs. the High Court of Judicature at Patna & Ors.

The Main (Written) Examination under the District Judge (Entry Level), Direct from Bar Exam-2021 has already been held on 24.07.2022 (Sunday) for 65 candidates whose Roll Numbers were published vide aforesaid Court's Notice

dated 26.05.2022 and one candidate having Roll Number 11940 was permitted to appear in the said examination provisionally in compliance of the order dated 22.07.2022 of the Hon'ble Supreme Court of India passed in Writ Petition (Civil) No. 542/2022 titled Amit Kumar vs. Hon'ble High Court of Judicature at Patna and Others. These 66 candidates are amongst the 94 candidates whose Roll Numbers are in the revised result.

Further, the remaining 28 candidates whose Roll Numbers are given below, are directed to appear in the Main (Written) Examination under the District Judge (Entry Level), Direct from Bar Exam-2021 to be held in view of the aforesaid Court's judicial order / judgment.

The date of Main (Written) Examination for the aforesaid 28 candidates is 19.03.2023 (Sunday) and the venue will be at Patna High Court, Patna. The Main (Written) Examination would consist of two theory papers of three hours duration each. The Theory Paper-I would be conducted from 10:00 A.M. to 01:00 P.M. and after lunch break Theory Paper-II would be conducted from 02:00 P.M. to 05:00 P.M.

Details / scheme of Main (Written) Examination as uploaded earlier vide Court's Notice dated 20.06.2022 is applicable for this examination

Note : 1. *Amongst 94 candidates shortlisted for the Main (Written) Examination, there are 51 candidates in UR Category against 3 vacancies; 13 candidates in BC Category against 1 vacancy; 28 Candidates in EBC Category against 6 vacancies; and 2 candidates in SC Category against 7 vacancies. The required number of SC & EBC candidates could not obtain the minimum qualifying marks of 40%, i.e. 115 marks out of 288, therefore, the number of the shortlisted candidates remained less than their requisite proportionate number. Further, no candidate of ST category could obtain minimum qualifying marks of 40%, i.e. 115 marks out of 288 against 1 vacancy.*
