This is for information that there were fifty (50) eligible officers who were under zone of consideration for promotion to the cadre of District Judge (Entry Level), against 65% quota for the year 2020-21. Out of them, three (03) officers were compulsorily retired and one (01) officer got superannuated. Thus, only forty six (46) eligible officers remained under zone of consideration for promotion.
