This is for information that there were one hundred and eighty five (185) eligible officers who were under zone of consideration for promotion to the cadre of District Judge (Entry Level), against 65% quota for the year 2021-22 & 2022-23. Out of them, one (01) officer was dismissed from service, one (01) officer got superannuated and one (01) officer got promoted to the cadre of District Judge (Entry Level) against 65% quota for the year 2020-21 and so appointed & posted as Additional District & Sessions Judge. Thus, only one hundred and eighty two (182) eligible officers remained under zone of consideration finally for promotion.
