HARDWARE TECHNICIAN ENGAGEMENT EXERCISE, 2023

The final result for engagement as Hardware Technician on contract basis initially for six months under Advertisement No.-PHC/CC-01/2023 for Hardware Technician Engagement Exercise, 2023 is being published alongwith this notice for information to all concerned. The candidates must take notice of following facts which have been taken into consideration for preparation of final result:

1. Total 40 candidates were shortlisted in view of the minimum qualification and experience as advertised vide Advertisement No. PHC/CC-01/2023, for appearing at the Interview. The interview was conducted for 100 marks out of which minimum qualifying standard was 40 marks.
2. Candidates securing marks equal and above the cut-off marks of Unreserved Category have been placed in the Unreserved Category while other candidates have been placed in their respective category of reservation.
3. If two or more candidates have secured equal marks, the candidate born earlier has been placed above.
4. The result has been prepared by following the 100 point roster-reservation policy adopted in the establishment of Court at the time of advertisement. The names of candidates are in order of merit and their category of selection is indicated against their names at Annexure-I.
5. The prepared result comprises 06 candidates under UR Category, 01 candidate under BC Category, 02 candidates under EBC Category and 01 candidate under SC Category. This result also includes 01 Orthopedically Handicapped candidate, who has been placed in his respective category of reservation.
6. The posts reserved for women candidates under horizontal reservation category has been filled up by male candidates of respective category because women candidates did not obtain the minimum qualifying standard fixed by the High Court, in view of Note (ii) of clause- 6 of the Advertisement.
7. The Cut-Off marks for each category is as follows:

8. Engagement Letters of selected candidates shall follow through Speed Post/ Registered Post.
9. Candidates selected under any of the reserved categories will have to produce certificates as mentioned in clause 6 of the advertisement issued by the competent authority, failing which their joining shall not be accepted.
10. Candidates will have to produce all the relevant documents regarding their educational qualification and experience in support of their claim to ascertain their eligibility as on 01.01.2023 for engagement as Hardware Technician in terms of the advertisement No. PHC/CC-01/2023. If a candidate fails to produce the required documents within the time as stipulated in the Engagement Letter, his joining shall not be accepted.
