The final result for appointment to the post of Personal Assistant under Advertisement No. PHC/03/2023 for Personal Assistant Recruitment Examination, 2023 is being published alongwith this notice for information to all concerned. The candidates must take notice of following facts which have been taken into consideration for preparation of final result:

1. Total 84 candidates who had attained the minimum qualifying standard in the Shorthand Computer Typing Test (Main) as prescribed in the Advertisement No. PHC/03/2023 were called for appearing in the interview.
2. Candidates bearing Roll Nos. PA230301194, PA230301199 and PA230301296 have been treated on the parameters of UR (Unreserved) candidate in all the stages of instant exercise and if any of them have failed to attain the required eligibility at any of the stages, they have not been considered further.
3. The candidates who have attained the minimum qualifying standard in the interview as prescribed in the Advertisement No. PHC/03/2023 have been considered for preparation of final result. The marks obtained by a candidate in the Shorthand Computer Typing Test (Main) alongwith marks obtained in the interview have been taken into consideration.
4. Candidates securing marks equal and above the cut-off marks of Unreserved Category have been placed in the Unreserved Category while other candidates have been placed in their respective category of reservation.
5. The result has been prepared after following the 100 point roster-reservation policy adopted in the establishment of Court at the time of advertisement. The names of candidates are in order of merit and their category of selection is indicated against their names at Annexure-I.
6. The prepared result comprises 14 candidates under UR Category including 06 female candidates, 03 candidates under EWS Category including 01 female candidate, 04 candidates under BC Category including 01 female candidate, 06 candidates under EBC Category including 02 female candidates and 01 candidate under SC Category.

7. The Cut-Off marks for each category is as follows:

8. A waiting list of candidates, at Annexure-II, has also been prepared in order of merit as per availability of candidates attaining prescribed minimum qualifying standard in their respective categories.
9. Appointment letters of selected candidates shall follow through Speed Post/ Registered Post. The candidates are advised to keep visiting the Court's official website regularly for further details / updates.
10. Candidates selected under any of the reserved categories will have to produce certificates as mentioned in clause 5 of the advertisement issued by the competent authority, failing which their joining shall not be accepted.
11. Candidates will have to produce all the relevant documents regarding their educational qualification in support of their claim to ascertain their eligibility as on 01.01.2023 for the post of Personal Assistant in terms of relevant Rules as well as the advertisement No. PHC/03/2023. If a candidate fails to produce the required documents within the time as stipulated in the Appointment Letter, his/ her joining shall not be accepted.
