On the basis of performance in the computer based written test comprising Multiple Choice Question based Objective Test for the **Assistant Cashier Recruitment Examination, 2024** (under **Advertisement No. PHC/02/2024**) held on 24th August, 2024 (Saturday) in single shift in Patna, total 12 candidates are hereby declared qualified for appearing at the Computer Proficiency Test & Interview for appointment to the post of Assistant Cashier in the establishment of this Court.

Candidates who have attained minimum qualifying criteria (as prescribed in the Advertisement) have been taken into consideration (marks-wise) for preparation of the result in the ratio of three times against vacancy advertised in each quota of reservation. All the candidates obtaining marks equal to the cut-off marks of their respective category have also been shortlisted for appearing at the Computer Proficiency Test & Interview.

Candidature of these candidates is provisional subject to their being found eligible in all respect. The candidates will be required to produce the original certificates in support of their claims pertaining to age, Minimum Qualification/ Eligibility Condition, Domicile Certificate, Non-Creamy Layer (NCL) Certificate/ Caste Certificate etc. at the time of document verification before their Interview. They are, therefore, advised to keep the said documents ready with them.

The date and schedule of Computer Proficiency Test of these candidates will be announced shortly on the official website of the Court. The Admit Card for appearing at the Computer Proficiency Test will be made available in due course, which may be downloaded from the official website of the High Court i.e. <https://patnahighcourt.gov.in>. Admit Card would not be sent to the candidates separately through any other mode.

No request for change in the schedule of Computer Proficiency Test shall be entertained.

The candidates are advised to keep visiting the Court's official website regularly for further details / updates.
